Directions to trial: Take Hwy 395 to Gardnerville. At the traffic signal at Hwy 395 & Waterloo Lane turn right (if coming from the south) OR turn left (if coming from the north) onto Waterloo Lane. Street names turn into Toler, then Fish Spring Road. Go approx. 5 ½ miles to Windmill Road. Turn Left on Windmill and go ¾ mile to the ranch at the corner of Windmill & Shena Terrace. Turn Right on Shena Terrace. Ranch entrance just past the 1st house on the right. Signs will be posted.
