Limited to 12 cattle, 15-20 sheep/goats, 15-20 Geese/Ducks & 10-15 mixed runs each trial

5-10 head Beef X cattle, 8-10 head Katahdin or Dorper X sheep, 8-10 Boer X goats, 5-10 head Buff X Geese & 8-12 Swedish or Magpie Ducks

**Sheep, Goats & Mixed \$55.00/run - Geese or Ducks \$50/run - Cattle \$65.00/run**

## Tentative Schedule:

### **Handlers' meeting 7:30 AM-all days.**

**Thur & Fri:** Geese walk at 7:30 AM & Sheep walk 30 minutes after Geese conclude

**Sat & Sun:** Cattle, Goats & Ducks walk TOGETHER at 7:30 AM / Mixed will walk 30 minutes after Cattle & Ducks conclude

**(Cattle & Ducks will run at the same time, followed by Mixed then Goats)**

**\*\*Trials will start immediately after meetings\*\***

10/8 - Geese then Sheep-both judged by **Marie**

10/9 - Geese then Sheep-both judged by **Carol**

10/10 - Cattle & Goats judged by **Carol** / Ducks & Mixed (ducks/goats) judged by **Marie**

10/11 - Cattle & Goats judged by **Marie** / Ducks & Mixed (ducks/goats) judged by **Carol**

**\*\*All entries must be postmarked and may not be postmarked before August 3, 2026. NO EXCEPTIONS. Entries accepted in postmarked order. Run order will be drawn before the trial. A waiting list will be established when or if trial fills.**

Dogs not registered with ASCA must have tracking number on entry to receive a title with ASCA. Tracking forms available at [www.asca.org](http://www.asca.org) If writing "pending" on entry, tracking number must be received by trial date or you will be required to re-apply at the trial.

**Awards:** FOUR Belt Buckles for high combined Advanced Aussie & Other Breed & Open Aussie & Other Breed. Special awards for High combined Cattle, Sheep/Goats, Mixed & Geese/Ducks over all days. Ribbons for 1<sup>st</sup> thru 4<sup>th</sup> placements & qualifying scores.

Ties will be broken by sort & another task as indicated on course directions & then by time

Garbage cans are available for trash and dog waste. Please clean up after your dog. If a gate was closed when you came thru it, please close it behind you. Please keep dogs on leash while on trial site.

Bitches in heat will be allowed & will run in order

No set out dog will be used in these trials

**Directions to Try Color Ranch:**

From Reno: 395 South to Hwy 88 (first signal as you come into Minden). Go right for about 5 miles. Watch for trial signs on right.

From Sacramento: Left side of Hwy 88 about two miles North of the California/Nevada state line.

From So. California: 395 North to first signal at South end of Gardnerville (Pinenut/Riverview). Go left past 7-11 (Riverview). Stay to the right and continue through two stop signs. At third stop sign go right and continue to Highway 88. Go left on 88 and travel about 1.25 miles. Watch for trial signs on right.

**Directions to Bitterbrush Herding Facility:**

Take Hwy 395 to Gardnerville. At the traffic signal at Hwy 395 & Waterloo Lane turn right (if coming from the south) OR turn left (if coming from the north) onto Waterloo Lane. Street names turn into Toler, then Fish Spring Road. Go approx. 5 1/2 miles to Windmill Road. Turn Left on Windmill and go 3/4 mile to the ranch at the corner of Windmill & Shena Terrace. Turn Right on Shena Terrace. Ranch entrance just past the 1st house on the right. Signs will be posted.
